IV. JUSTIFICATION OF REQUEST

Over the past three months, the cost per KWH has increased at an average rate exceeding 30%. As the cost of fuel continues to increase so will our electricity bill. Some of our rooms and buildings require air conditioners to be in operation 24 hours a day, 7 days a week to preserve research specimen and also to avoid over heating of major equipment, such as computer servers.

As many students are attending classes around their work schedules, classes are offered in the evening to accommodate this non-traditional student population. The campus is open and in high use during the evenings not only for classes, but also for lab work and research projects. Lights must be kept on in classrooms, buildings and for safety purpose, external areas such as the parking lot and walkways.
